- RETURN TO RACE OFFICE BY: (1) APPLICATIONS NOT COMPLETED IN DETAIL WILL NOT BE ACCEPTED
(2) ALL ORIGINAL PAPERS PERTAINING TO THE HORSES LISTED BELOW and any additional horses MUST BE FILED WITH THE RACE OFFICE UPON ARRIVAL.
(3) COGGINS MUST BE IN THE RACE OFFICE 48 HOURS PRIOR TO ARRIVING ON THE GROUNDS. ORIGINAL PAPERS OR DIGITALS MUST BE IN THE OFFICE UPON ARRIVAL TO THE GROUNDS.
(4) ANY HORSE OR HORSES FAILING TO MEET THE ABOVE REQUIREMENTS WILL BE REFUSED ENTRY. Stall Fees may apply for horses that do not start in Lethbridge or Horses that train in Lethbridge & race other than Lethbridge and Millarville will be subject to training fees. Only stalls allocated by RMTC are to be used.
(5) ALL PERSONEL MUST BE LICENSED BY HRA & TRAINERS MUST HAVE A WORKMEN’S COMP #

IMPORTANT – READ CAREFULLY**

**STALLS ASSIGNED UNDER THE FOLLOWING CONDITIONS; YOUR SIGNATURE ON REVERSE SIDE INDICATES
THAT YOU AGREE TO BE SUBJECT TO THE FOLLOWING CONDITIONS, RULES ETC.**

- (1) The granting of stalls pursuant to this application in whole or in part shall not constitute a lease of space but a revocable license only.
- (2) I AGREE that any and all substitutions for the horses named on the front hereof and any and all changes of the conditions of the same, must be approved in writing by Rocky Mountain Turf Club prior to date of shipping. The horses named on the front hereof and all substitutions approved as aforesaid shall be hereinafter called “the horses.”
- (3) I AGREE that as and when from time to time, any of the horses are dropped from training or are not to be raced at the Meeting in progress I will immediately inform Rocky Mountain Turf Club in writing giving the name of such horses.
- (4) Rocky Mountain Turf Club shall not be liable for injury or loss suffered in any manner to me or any personal employed by me or to a horse or horses belonging to me or to those for whom I am agent or trainer, while on the premises, whether caused by the condition of the premises or otherwise.
- (5) I AGREE to indemnify and hold the Rocky Mountain Turf Club, its officers, employees and agents, harmless against any and all claims, liabilities, losses, costs, damages and attorney fees incurred by reason of the conduct of negligence of the undersigned or of his agents or employees, but this indemnity shall not extend to liabilities, claims, losses damages or attorney fees arising out of the negligence or wilful acts or omissions of the Rocky Mountain Turf Club or their respective agents or employees.
- (6) I AGREE to abide by and be governed by the lawful rules of racing of Horse Racing Alberta.
- (7) I AGREE that this contract is made with and shall ensure to the benefit of the Rocky Mountain Turf Club.
- (8) I AGREE to remove my horses and/or those in my possession, charge or control together with all personal property belonging to me, or of which I have possession, charge or control from the grounds of the Rocky Mountain Turf Club forthwith upon the expiration of twenty-four (24) hours after the Rocky Mountain Turf Club has given me notice in writing to vacate the stabling accommodation, which notice may be given for reasonable cause with said reason or cause being stated or given. Any such notice or any other notice given hereunder shall be sufficiently given by posting up such notice on some portion of the stabling accommodation allotted to me and such notice shall be deemed to be given at the time when the same is posted up. I understand that my employees shall leave the premises, Rocky Mountain Turf Club forthwith upon the expiration of twenty-four (24) hours after notice has been given as aforesaid. I agree that if upon the expiration of the said twenty-four (24) hours notice hereinbefore mentioned, any horse or horses or personal property belonging to me or in my possession, charge or control, have not been removed from the said Rocky Mountain Turf Club premises, shall be entitled to remove the same from the said premises without further notice, either to a public pound, or the Rocky Mountain Turf Club may stable the same at my expense elsewhere and the Rocky Mountain Turf Club shall in no event, either jointly or severally be responsible for any such horse or horses removed as aforesaid. I AGREE that in the event of the horses being stabled elsewhere at my expense as aforesaid that the person, firm or corporation stabling the horses or paying for the stabling of same shall have all the rights of the keeper of a boarding stable under The Livery Stable Keepers Act.
- (9) It is understood that the Rocky Mountain Turf Club reserve the right at any time to deny admission to Rocky Mountain Turf Club premises to me or my employees or to my agents or any persons under my control or any person, firm or corporation contracting with me.
- (10) I AGREE that I will not mutilate or in any way damage the accommodation allotted to me and further that I will not make or permit to be made any structural changes in the said stabling accommodation; that I will be responsible for all damage to the stabling accommodation allotted to me while the horses or any of them are stabled therein; that I will keep such stabling accommodation in good and clean condition and deposit the manure and litter where directed by the Rocky Mountain Turf Club.
- (11) I AGREE that there is no representation, warranty, or collateral agreement given or made by the Rocky Mountain Turf Club affecting this agreement other than expressed herein in writing.
- (12) All assigned stalls must be cleaned when leaving, if you leave early, contact office for inspection. There is a charge for uncleaned stalls. RMTC reserve the right to charge stall rent.
- (13) ABSOLUTELY NO DOGS IN THE BARN AREA.

NOTE: It should be remembered that demand is likely to exceed stall space, therefore, limitations of space may force this Association to turn down all or part of your stabling request.

Since we do have a shortage of stalls, please adhere to the following rules: any horse stalled on the grounds will be entered at least once every 15 days. If the horse draws in and is a scratch, it must be re-entered the following week or may be asked to be taken home for recovery. Stalls charges may apply. If a horse leaves RMTC to race at another race track while live racing is still on in Lethbridge (other than Millarville) there may be a stall rental fee. (See race office for details).
